

May Tech Program

Advanced Water Restoration



Cliff Roe

Cliff Roe worked 27 years as a general contractor which included new construction with Walbridge Aldinger and as an operator for underground piping systems at the University of Michigan Hospital in Ann Arbor, MI. In 2002, he started working on a drinking water distribution monitoring system. In 2004, Jim Ridgway, President of DynamOx, brought him in to redesign the DynamOx System, make mechanical design

changes to previously failed testing equipment and demonstrate the science behind this new technology would work.

Program: Henry's Law states: At a constant temperature, the amount of a given gas dissolved in a given type and volume of liquid is directly proportional to the partial pressure of that gas in equilibrium with that liquid. 

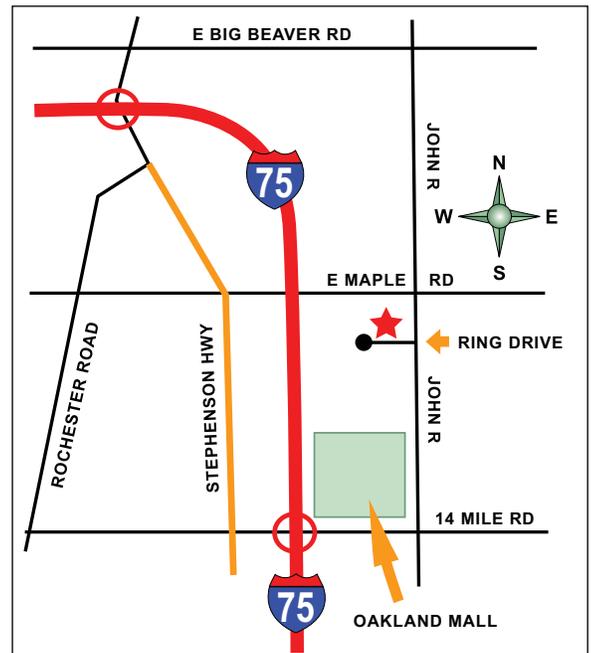
